Sub: LETTER OF EMPLOYMENT.

We refer to your application seeking employment with **RuralShores Business Services Pvt. Ltd.,** (Company) and also the subsequent interview discussions you had with us.

We are happy to offer you Employment with the Company as **Process Associate** in **Grade A2, Service Delivery**, subject to the service rules of the Company that are in force and that may be introduced from time to time, in addition to the terms and conditions hereinafter set out:

1. APPOINTMENT

- 1.1 Your appointment as **Process Associate** Commences from **20-03-2021** (Date of joining) and you will be on probation for a period of **six (6) months**.

2. REMUNERATION

- 2.1 Your annual emoluments will be Rs1,57,224 /- (Rupees One Lakh Fifty Seven Thousand and Two Hundred Twenty Four Rupees only). The breakup of emoluments is as per **Annexure A**. The salary payable to you would be subject to statutorily applicable deductions on account of income tax deducted at source, provident fund payments, employee state insurance (ESI) payments, professional tax, labor welfare fund payments, etc., and any other deductions as per Company's policies and practices. Generally, Salary shall be paid into your bank account by the last day of each month.

3. PROBATION & CONFIRMATION

- 3.1 At the end of probation period of six (6) months, if the Company feels that there is a need to extend the term of probation based on your performance, overall behavior; the Company shall do so and provide the duration of such probation in writing.
- 3.2 In the absence of such a communication, your services shall be deemed to have been confirmed in the Company at the end of six (6) months of probation.

4. PLACE OF WORK

- 4.1 Your initial place of work will be Company's Office located at **Dhawalgaon**, India.
- 4.2 However, considering Company requirements, you may be transferred to any other location, any of the affiliates, subsidiaries, and / or sister concern(s) as may be decided by the Company.
- 4.3 In such situations, you will be required to report at the designated location as per the terms and conditions contained in the transfer letter without being eligible for any additional remuneration, benefits etc. unless specified otherwise.
- 4.4 On reporting at the designated location of RSBS, you will be governed by the service rules, policies and terms and conditions as applicable at the location of RSBS to which you are transferred.
- 4.5 During the course of employment with RSBS, you may be required to travel and work in India and / or overseas at any of the Company's establishments or client sites for the purposes of providing the services of the Company.

5. NOTICE OF TERMINATION

- 5.1 During the term of probation, your employment with the Company can be terminated by either party, by giving the other, two month prior written notice or payment in lieu thereof. In such cases, it should be noted that the Company reserves the right to settle your dues / benefits / payments and / or issue relieving letter; service certificates etc.
- 5.2 After confirmation of your service by the Company, your services can be terminated by either party by giving one month prior written notice or payment in lieu thereof.
- 5.3 It is to be noted herein that during the notice period you shall not be entitled to any leaves unless there are medical or other family emergencies.
- 5.4 Notwithstanding anything stated above, your date of relieving from the Company may be extended until the completion of certain works or projects which you are entrusted with to

do or until complete knowledge transfer has been made by you to the Company or a suitable replacement is found for your position and the Company approves the same in writing.

- 5.5 If your actions at any time constitute a serious breach of Company's standards of behaviour in spite of receiving notice from the Company to rectify the same either verbally or in writing, Company shall terminate your employment with immediate effect without any notice or payment in lieu thereof whatsoever.
- 5.6 In case of your resignation, Company reserves the right upon receiving notice from you, to waive such notice period and pay gross salary for the duration of notice period waived. Kindly note that gross salary for the purposes of this clause would mean only your monthly gross salary and would not include any allowances, reimbursements, perquisites or benefits.

6. DUTIES AND OBLIGATIONS

- 6.1 You shall hereby agree and confirm that you will devote full time and attention to provide the services and perform such other duties as required by the Company. You also agree to use the best efforts in the performance of your duties and responsibilities and shall perform all the duties with due care, skill and diligence.
- 6.2 You shall be entitled to leave with wages and other applicable leaves as per the policies of the Company as applicable to you.
- 6.3 You shall, during the term of your Employment with the Company, refrain from absenting from work without reasonable cause and prior written approval and / or consent for the entire period for which you are stipulated herein as having to work for the Company.
- 6.4 You shall ensure that during the term of your Employment with the Company, you shall not commit any act or misconduct, or commit any acts subversive to the discipline of the Company, or otherwise misbehave in a manner that would be construed as being in violation of the rules and regulations of the Company in force from time to time including the terms and conditions contained in this letter of employment.
- 6.5 You agree that during the term of your Employment with the Company you shall work exclusively for the Company and that you will not perform or undertake to perform any work for any other person and / or Company without the prior written permission of the Company. For the purposes of this clause, "work" shall mean and include any job, service, consultation, training, piece-work, part-time work or contract work carried out by you for the benefit of any legal entity either yourself or through any other person or legal entity for monetary gain or otherwise.
- 6.6 You shall not have the right or the authority to make any representation, contract or commitment for or on behalf of the Company without obtaining the prior written permission of the Company in this regard. You shall have no authority, implied or otherwise, to pledge the credit of the Company. In the event the Company is held liable for any damage, loss, claim or action arising directly or indirectly from any of your action in violation of this clause, you shall indemnify the Company to the maximum extent permissible under the laws for the time being in force in India.
- 6.7 You shall take good care of all equipment's / tool / aids / materials / documents and other items of the Company entrusted to you and shall not misuse for personal usage or benefit or gains.

- 6.8 You also agree and confirm that you will not seek; solicit or make or accept any favors from Employees, Colleagues; Clients; Vendors; Center Partners etc., in any form including but not limited to financial assistance; material in kind or in any other form during the course of employment with the Company.

7. NON-COMPETE AND NON-SOLICITATION:

- 7.1 You shall not, during the continuance of your employment with the Company or after the date of termination of employment, directly or indirectly solicit or entice away or endeavor to solicit or to entice away or assist any other person to solicit or entice away from the Company any individual who is in employment of the Company.
- 7.2 During your employment or thereafter, you will not knowingly interfere with or disrupt or attempt to interfere with or disrupt, the relationship, contractual or otherwise, between the Company and any customer or client, potential customer or client.
- 7.3 You agree that any material breach or written threatened breach of this clause may not be remedied solely by money damages, and that in addition to any other remedies, the Company is entitled to seek injunctive relief against you in a Court of competent jurisdiction for any such breach.
- 7.4 The restrictions contained in this clause are considered to be reasonable in all the circumstances for the protection of the legitimate interests of the Company and shall be enforceable independently.
- 7.5 If any restriction set forth in this clause 5 is found by any court of competent jurisdiction to be unenforceable because it extends for too long a period of time or over too great a range of activities or in too broad a geographic area, it shall be interpreted to extend only over the maximum period of time, range of activities or geographic area as to which it may be enforceable.

8. CONFIDENTIALITY

- 8.1 You recognize that you are being hired in a position of trust and confidence with the Company and will in the course of your employment with the Company, be exposed to various items of secret and confidential information that are proprietary to the Company. You acknowledge that the Company needs to protect such secret and confidential information, covenants to hold any such information in trust for the Company and undertake not to disclose such information to any third party.
- 8.2 You may have access to any confidential information, documents, files, content during the term of your employment with the Company. You further agree that to the extent you have access to such information, intentionally, by accident, or otherwise, you will keep such information confidential and not further disclose or use such information to any person or entity unless such use or disclosure is necessary to carry out your related responsibilities. If you breach this confidentiality, appropriate disciplinary action up to and including termination of employment without any notice or compensation in lieu thereof may be initiated.
- 8.3 You represent that your performance of the terms of this Letter of Employment and your employment with the Company does not and will not breach any agreement to keep in confidence information previously acquired by you in confidence from any third party. You have not entered into and agree not to enter into, any agreement in conflict with this Letter of Employment or which in any way prohibits your performance of or restricts your ability to perform your obligations under this Agreement.

9. COMPENSATION AND BENEFITS

- 9.1 You acknowledge and understand that Company shall make all required withholdings relating to your compensation, including, without limitation, income taxes, professional taxes, and contributions towards Employee State Insurance (ESI), Provident Fund (PF), Gratuity and any other withholdings required by law or court order.
- 9.2 You will be eligible for Membership of Provident Fund as applicable to you. The membership will be as per rules framed from time to time.
- 9.3 You will also be eligible to participate in the Company's Health Insurance benefits, if you are not covered under the ESI provisions and as may be applicable to you from time to time.
- 9.4 The Company reserves its right to add, amend, introduce or withdraw any or all of the salary and / or compensation benefits without assigning any reason whatsoever.
- 9.5 ***The Company classifies Salary and Compensation information as "Confidential". Any exchange of information in this regard is limited to authorized personnel of the Company such as HR, Finance and Head of the Department. Divulging any confidential information to unauthorized person may result in strict disciplinary action including but not limited to termination of employment.***

10. TERM AND TERMINATION

- 10.1 The term of the employment with the Company shall commence from **your date of joining as mentioned above (refer clause 1.1)** and shall continue until termination in accordance with clause 5 or clause 10 of this Letter of Employment.
- 10.2 Notwithstanding anything contained clause **Five (5)** above, the Company shall be entitled to terminate the employment forthwith without any notice or compensation in lieu thereof, in the event of you:
- (a) Neglect or fail to attend to the business of the Company or fails to comply with the directions of the Company including but not limited to discharge of responsibilities, safety, security guidelines as stipulated by the Company;
 - (b) Breach of any of the terms of this Letter; or any rules and regulations of the Code of Conduct, Standing Orders, Policies and Procedures of the Company.
 - (c) If you remain absent without prior approval or sanction of leave for 3 consecutive working days including extended days of absence.
 - (d) You are unable to work because of any contagious illness or if you are found medically not fit to perform the work assigned to you;
 - (e) You are found guilty of any misconduct as defined under law or under the relevant provisions of the rules and regulations of the Company as notified to you from time to time; Commission or omission of any act, misconduct as per the Service Rules and / or Standing Orders of the Company.
 - (f) If you are found guilty for any reason and are arrested by police or convicted by any court of law. If you are involved in any riotous; retaliation; violence activities within or outside the office premises; or found involved in any harassment activities including sexual harassment

11. RETIREMENT

- 11.1 In normal circumstances, you will retire from the services of the Company on attaining the age of 60 years. The age proof submitted by you shall be considered as the final proof for calculating the age of retirement.

12. JURISDICTION

- 12.1 In case of any disputes between yourself and the Company, the Courts at Bangalore shall have jurisdiction to adjudicate any such matters.

This appointment is subject to your being certified medically fit by a registered medical practitioner. The Company shall have the right to order you to undergo the medical test at any time during your service to determine fitness. In the event of you being found unfit for the work for which you are employed, the company shall have the right to terminate your service based on such reports in accordance with the terms contained in this letter.

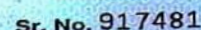


